RETURN OF THE RETURNS FROM CRISIS TO V SHAPE RECOVERY AND MORE...

Welcome to our latest AIF Performance newsletter with performance data as of 30th Nov 2020 Nothing has changed mankind as much as COVID has. The early days of COVID were marked with the highest level of panic and fear. Stock markets naturally mirrored the same kind of fear and panic so much so that circuit filters were implemented on India's benchmark NIFTY 50 index. Year 2020 has been a phenomenal year for traders as well as investors as Nifty 50 itself showed a swing of - 40% to + 80%, a whopping 120% momentum.
