## The Domestic Anchor: Navigating Global Tides with Indian Conviction

Dear Investor,

Having navigated markets through four complete cycles—I've learned that sustained alpha generation comes not from chasing market momentum, but from partnering with advisors who prioritize data over drama. new economic narrative. This moment, we think, deserves your attention.

The Month of August provided a masterclass in the importance of this experienced navigation. Global headwinds intensified with the imposition of US tariffs, triggering significant FII outflows of nearly ₹47,000 crore in August. Yet, a historic inflection point emerged: Domestic Institutional Investors (DIIs) stepped in with unprecedented conviction, absorbing the selling with net purchases of over ₹94,800 crore. This trend has continued forcefully into September, providing a powerful floor to the market. This is the clearest signal yet that Indian markets are no longer hostage to foreign sentiment.

While short-term traders panicked over tariff headlines, the underlying economic engine was firing on all cylinders. India's Manufacturing PMI surged to 59.3 in August—the highest level since February 2008 and the fastest improvement in operating conditions in 17.5 years. This is not a cyclical uptick; it is evidence of a structural manufacturing renaissance, bolstered by the "China Plus One" strategy and pro-growth domestic policies. While the tariff noise created volatility, India's strong external buffers—a current account deficit of just 0.2% of GDP in Q1 and forex reserves providing robust coverage of external debt—provided immense stability.

This period was a real-time validation of our core principle: volatility is the price of admission for superior returns. While others reacted to headlines, disciplined, long-term investors accumulated quality assets, supported by steady SIP flows that remained strong at over ₹28,000 crore in August. This is the emotional arbitrage that professional management provides—recognizing temporary external shocks versus a structural deterioration in fundamentals.

The evidence is overwhelming. The confluence of a manufacturing ascendancy, the maturation of our financial markets powered by domestic capital, and a clear policy architecture has crystallized my conviction that India is entering its most compelling wealth creation period since liberalization. This is India's Amrit Kaal—our golden era. For investors with the discipline to remain committed through short-term volatility, the wealth creation potential is extraordinary.
